City of Conway -- City Council Brief  
February 26<sup>th</sup> 2008

At its meeting the Conway City Council took the following actions:

**Ordinances Passed:**

- Ordinance {O-08-21} appropriating funds in the amount of \$99,641 for the Salem Sidewalk Improvement (Saddletop Center to Carl Sturat Street). **Vote 8-0**
- Ordinance {O-08-22} appropriating funds in an amount not to exceed \$535 to replace the roof at the Physical Plant Department. **Vote 7-0 w/ Alderman Jones not present.**

**Ordinances Failed: None**

**Resolutions Passed:**

- Resolution {R-08-09} in support of a safe routes to school grant application for sidewalks, pedestrian/bike trail improvements and street crossing along Siebenmorgan Road, Bob Courtway Drive and East German Lane. **Vote 7-0**

- ♦ Approved minutes from the February 12, 2008. **Vote 8-0**
- ♦ Approved a conditional use permit for two duplexes for property located at the northwest corner of Washington Avenue and Fleming Street located at 1606 Fleming Street. **Vote 8-0**
- ♦ Approved the low bid in the amount of \$12,535 from Jancour for a new roof for the Physical Plant. **Vote 8-0**
- ♦ Approved to accept the low bid from MHC Hino (Little Rock) in the amount of \$56,874 for a new 2008 dump truck for the Parks Department. **Vote 7-0**
- ♦ Approved to accept the low bid from David's Small Engine in the amount of \$30,437.46 for (3) new mid-mount zero turn radius mowers with side discharge for the Parks Department. **Vote 7-0**

- ◆ Approved entering into an agreement with the Conway Housing Authority for a full time community policing officer. **Vote 7-0**
- ◆ Approved to accept the low bid from Bale Chevrolet in the amount of \$24,130.23 to purchase a 2008 ¾ ton 4x4 truck for the Conway Sanitation Department. **Vote 7-0**
- ◆ Approved the boat docks by Treasure Hills Property Owners Association and also approved that they pay the past year and this year annual fees for each of the docks. **Vote 5-2 w/Alderman Vaught & Mehl voting against.**
- ◆ Approved moving the next regularly schedule city council meeting (March 11<sup>th</sup>, 2008) to Thursday, March 6<sup>th</sup>, 2008. **The deadline for agenda items will be Monday, March 3<sup>rd</sup>, 2008 by noon.**
