At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-08-37} appropriating funds in the amount of \$20,000 for expenditures associated with the new airport. **Vote 8-0**
- Ordinance {O-08-38} appropriating revenue funds in the amount of \$17,654 for repairs to the D6 CAT Dozer. **Vote 8-0**
- Ordinance {O-08-39} authorizing District Court to disburse certain fines to Faulkner County on behalf of the City. **Vote 8-0**
- Ordinance {O-08-40} waiving bids & providing sole source status for tasers and taser cartridges for the CPD. **Vote 8-0**

Ordinances Failed: None

Resolutions Passed:

- Resolution {R-08-10} setting a public hearing on April 22nd, 2008 to discuss the closing of an easement in Runaway Subdivision. **Vote 8-0**
- Resolution {R-08-11} requiring an audit of the accounting records for the City of Conway. **Vote 8-0**

In other actions, the Council:

- ♦ Approved minutes from the March 25th, 2008 Council Meeting. **Vote 8-0**
- ♦ Approved providing the downtown post office with four additional Parking signage for 24 hour access. **Vote 7-0 w/ Alderman Jones abstaining.**
- ♦ Approved the bids for turnout gear by Pro-Fire Equipment in the amount of \$1,756.90 for the Conway Fire Department. **Vote 8-0**

- ◆ Approved entering into an agreement with Southwest Solutions Groups and utilizing US Communities for the purchase of a Spacesaver High Density system. **Vote 8-0**
- Approved entering into an agreement with JPMS/Cox letter to engage Jeffrey, Phillips, Mosley, & Scott to conduct annual financial audit. **Vote 8-0**
