November 25th, 2008

At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-08-132} rezone property located at 2730 Dave Ward Drive from RMH to MF-1. **Vote 5-4 w/ the Mayor voting with the majority and Alderman Jones, Whitmore, Grimes, & Smith voting against.**
- Ordinance {O-08-144} authorizing the issuance and sale of taxable electric franchise fee revenue bonds for Hewlett Packard. **Vote 8-0**
- Ordinance {O-08-145} to annex certain lands which have been completely surrounded by the incorporated limits of City of Conway. **Vote 8-0**
- Ordinance {O-08-146} to rezone property located at 800 South Harkrider to C-3 to I-3. **Vote 8-0**
- Ordinance {O-08-147} waiving bids for the purchase of Holmatro Rescue Equipment in the amount of \$37,420 and utilizing Pro Fire Equipment for the CFD. **Vote 8-0**
- Ordinance {O-08-148} to authorize personnel changes within the Conway Fire Department. **Vote 8-0**

- Resolution {R-08-45} to enter into a five year extension of the interlocal agreement for ambulance service with MEMS. **Vote 8-0**

- Approved to authorize payment for work related to the Special Event Pavilion. **Vote 7-1 w/ Alderman Vaught voting against.**
- Approved the bid from Cruse Uniforms in the amount of \$8,965.39 after trade of duty weapons for the Conway Police Department. **Vote 8-0**
- Approved the authorization of reclassification of several positions within the CEOC. **Vote 8-0**
- Approved accepting an additional two year of health club membership from Extreme Fitness for City employees & retirees. **Vote 8-0**
- Approved moving the December 23rd City Council meeting to December 16th, 2008. **Vote 8-0**
