City of Conway -- City Council Brief
December 9th, 2008

At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-08-149} appropriating funds in the amount of \$264,982 for Harkrider St Improvements project. **Vote 7-1 w/ Alderman Vaught voting against. (Emergency Clause passed 8-0)**
- Ordinance {O-08-150} appropriating revenue funds in the amount of \$3,253.63 from the Arkansas Municipal League to the Sanitation Department for vehicle damages. **Vote 8-0**
- Ordinance {O-08-151} accepting grant proceeds in the amount of 12,343 from ADEQ & appropriate funds to the Sanitation Department. **Vote 8-0**
- Ordinance {O-08-152} appropriating funds in the amount \$64,000 for recycling efforts at the Conway Sanitation Department related to the Styrofoam Densifier. **Vote 8-0**
- Ordinance {O-08-153} waiving bids for the Sanitation Department to purchase one container/compactor and one self compactor from QLL Equipment Company at a total cost of \$29,675. **Vote 7-0-1 w/ Alderman Thompson abstaining.**
- Ordinance {O-08-154} accepting court ordered forfeiture assets from the Circuit Court to the Conway Police Department. **Vote 8-0**

Ordinances Failed: None

Resolutions Passed:

- Resolution {R-08-46} setting a public hearing to discuss closing a drainage and utility easement located in the Cresthaven Subdivision, Phase III. **Vote 8-0**
- Resolution {R-08-47} establishing the intent of the City of Conway to annex certain land South of Prince Street which has been completely surrounded by the city limits. **Vote 8-0**
- Resolution {R-08-48} authorizing the Mayor to proceed with Dave Ward Drive & Donaghey Intersection; Harkrider Projects; Salem Road, Sturgis Road, & Stanley Russ Street Improvement Projects. **Vote 8-0**

- Approved the minutes from November 25th, 2008 City Council Meeting. **Vote 8-0**
- Approved the extension to a conditional use permit for the Ward bed & breakfast located at 1912 Caldwell Street. **Vote 7-1 w/ Alderwoman Whitmore voting against.**
- Approved to accept bids from Gwatney Pontiac Buick GMC for a one ton truck (4 door crew cab) in the amount of \$23,995 and a one ton standard cab truck in the amount of \$19,251 for the Street Dept. **Vote 8-0**
- Approved to accept bids from Handi Ramp for a Mobile Loading Ramp in the amount of \$15,846.53 for the Sanitation Department. **Vote 8-0**
- Approved to accept bids from Recycle Tech in the amount of \$64,000 to purchase a Styrofoam Densifier for the Sanitation Department. **Vote 8-0**
- Approved to remove fixed assets (duty weapons) from the inventory listing and to dispose of these items for the Conway Police Department. **Vote 8-0**
