**At its meeting the Conway City Council took the following actions:**

**Ordinances Passed:**

- Ordinance {O-09-86} amending Ordinance O-06-139 in reference to the Old Conway Design Overlay District. **Vote 8-0**
- Ordinance {O-09-87} accepting the annexation of certain lands along the east side of Old Military Road north of Deerbrook Subdivision. **Vote 8-0**
- Ordinance {O-09-88} to rezone property located at 2501 East Oak from R-1 to I-3. **Vote 7-1 w/ Alderman Vaught voting against.**
- Ordinance {O-09-89} waiving the requirements to obtain competitive bids and appropriating funds in the amount of \$29,060 for equipment repairs for the Sanitation Department. **Vote 8-0**
- Ordinance {O-09-90} waiving bids for insurance coverage for the City's vehicle and property and shall insure those assets with the Arkansas Municipal League. **Vote 8-0**
- Ordinance {O-09-91} rezoning property located on the northwest corner of the intersection of South Donaghey Avenue and Moix Blvd. **Vote 7-1 w/ Alderman Jones voting against.**
