- Ordinance {O-09-93} appropriating funds in the amount of \$12,910.98 for the purchase of a Flex Wing Rotary Cutter for the Sanitation Department. **Vote 7-0**
- Ordinance {O-09-94} appropriating funds from the District Court automation in the amount of \$8,536 for office equipment (Digital Copier). **Vote 7-0**
