**City of Conway -- City Council Brief
December 8th, 2009**

At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-09-141} closing the 15' extended overhead electric utility easement located in part of Block 6 of the west end addition at 2740 College Ave. **Vote 8-0**
- Ordinance {O-09-142} to abandon a portion of the Western Avenue right of way at the northeast corner & southeast corner of Prince Street & Western. **Vote 8-0**
- Ordinance {O-09-143} to accept additional funding in the amount of 25,098 and appropriating the grant revenue funds to CDBG. **Vote 8-0**
- Ordinance {O-09-144} to waive bids for contracted services with Terracon Consultants Inc. in conjunction with the City Landfill testing. **Vote 8-0**
- Ordinance {O-09-145} to waive competitive bids and appropriate funds in the amount of \$15,904 for clearing services through Tucker Creek Bike Trail. **Vote 8-0**
- Ordinance {O-09-146} adopting the budget for the FY 2010 for the City of Conway. **Vote 8-0**
- Ordinance {O-09-147} to waive bids and for purchase 12 (twelve) patrol cars from Landers Brothers Chrysler Dodge Jeep for the Police Department. **Vote 8-0**
- Ordinance {O-09-148} to waive bids and purchase 2 (two) fire truck from Pro Fire Equipment for the Fire Department. **Vote 8-0**
