**Ordinances Passed:**

- Ordinance {O-10-23} appropriating revenue funds in the amount of \$17,150 received from Marck Industries to the Conway Sanitation Department. **Vote 8-0**
- Ordinance {O-10-24} appropriating insurance proceeds in the amount of \$1,655 received for fire engine repairs to the Conway Fire Department. **Vote 8-0**
