*On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum, were present and acting; Alderman Hawkins, Alderwoman Smith, Alderman Grimes, Alderwoman Mehl, Alderman Vaught, Alderman Jones, Alderman Rhodes & Alderwoman Whitmore. Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael Garrett, and City Attorney Michael Murphy.*

***At its meeting the Conway City Council took the following actions:***

**Ordinances Passed:**

- Ordinance {O-10-25} revising the nuisance abatement and property maintenance chapter of the Conway Municipal Code & revising the sign ordinance. **Vote 8-0**
- Ordinance {O-10-26} to rezone property located south of Bay Town Drive at the western terminus of Burnt Pine Drive from A-1 to R-1. **Vote 8-0**
- Ordinance {O-10-27} to rezone property located at 1915 Richsmith Drive from O-1 to MF-3. **Vote 6-2 w/ Alderman Rhodes & Alderwoman Whitmore voting against.**
- Ordinance {O-10-28} amending the Conway Sign Ordinance, (section 1301) in reference to pre-existing non conforming signs. **Vote 8-0**
- Ordinance {O-10-29} amending the municipal code Title 12 (Lake Beaverfork) in regards to structures (Section 22). **Vote 8-0**
- Ordinance {O-10-30} appropriating funds for asphalt paving and stripping of the additional parking lot at City of College Park. **Vote 8-0**
- Ordinance {O-10-31} prohibiting smoking and the use of tobacco products in Parks & Recreation areas in the City of Conway. **Vote 7-1 w/ Alderman Vaught voting against.**
- Ordinance {O-10-32} appropriating funds in the amount of \$12,873 from District Court automation fund for a surveillance system. **Vote 8-0**
- Ordinance {O-10-33} adopting budget adjustments for City of Conway. **Vote 8-0**
