On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum, were present and acting: Alderman Hawkins, Alderwoman Smith, Alderman Grimes, Alderwoman Mehl, Alderman Vaught, Alderman Jones, Alderman Rhodes & Alderwoman Whitmore. Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael Garrett, and City Attorney Michael Murphy.

At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-10-42} authorizing the issuance of industrial development revenue bonds for Kimberly-Clark. **Vote 8-0**
- Ordinance {O-10-43} amending the mechanical permit fees for the construction and alterations of mechanical systems in buildings in the City. **Vote 7-0 w/ Alderman Smith not present.**
- Ordinance {O-10-44} waiving bids for G.W. Diesel Service for repairs (\$12,100) to a residential trash truck for the Conway Sanitation Dept. **Vote 6-0 w/ Alderwoman Smith & Alderman Jones not present.**

Ordinances Failed: None

Resolutions Passed:

- Resolution {R-10-15} setting a public hearing (May 25th, 2010 @ 6:30pm) to discuss renaming Sutton Street. **Vote 8-0**
- Resolution {R-10-16} requesting the Faulkner County Tax Collector to place a certified lien on property located at 809 Walnut Street as a result of incurred expenses by the City. **Vote 8-0**

In other actions, the City Council:

- Approved the minutes from April 27th, 2010 City Council Meeting. **Vote 8-0**

- Approved the lease of 2.2 acre land for farming & the relocation of Owen Road to the south boundary of the Moon property. **Vote 8-0**
- Approved to accept the low bid from Contractors Specialty Company in the amount of \$83,675 for pavement markings (striping & symbols) for the year 2010. **Vote 5-0 w/ Alderman Grimes, Jones & Alderwoman Smith not present.**
- Approved a change order agreement from F.P. Bivens for additional parking for Pompe Park located off Prince Street in the amount of \$7500. **Vote 6-0 w/ Alderman Jones & Alderwoman Smith not present.**
- Approved to hold off on the purchasing of bicycle racks for the City of Conway. **Vote 6-0**
- Approved to provide funding for the Senior Citizens Program, FCCDD, & Boys & Girls Club for transportation needs until June 30, 2010. **Vote 6-0**
- Approved a right of way easement located at Little Creek for Conway Corporation. **Vote 6-0**

- Resolution ordering the demolition of a structure located at 335 Natchez Trail and declaring the intent of the City to bring the property up to code. **Vote 8-0**
- Resolution ordering the demolition of a structure located at 1910 Hillman and declaring the intent of the City to bring the property up to code. **Vote 8-0**
- Ordinance amending the permit fees for the construction and alterations of buildings and building systems in the City. **(Item was pulled by applicant)**
