On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum, were present and acting; Alderman Hawkins, Alderwoman Smith, Alderwoman Mehl, Alderman Vaught, Alderman Rhodes & Alderwoman Whitmore. Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael Garrett, and City Attorney Michael Murphy. Alderman Grimes was not present.

At its meeting the Conway City Council took the following actions:

Ordinances Passed:

- Ordinance {O-10-54} closing the right of way located between Lots 65-74 of Creekwood Subdivision and Lots 1-7 of Charles Place Subdivision, known as the Old Donaghey Right of Way. **Vote 7-0 w/ Alderman David Grimes not present.**
- Ordinance {O-10-55} accepting additional federal funding and appropriating additional grant revenue to the CDBG Program. **Vote 7-0**
- Ordinance {O-10-56} providing for the regulation of off-street bicycle parking and loading facilities and to specify requirements for off-street parking and loading facilities. **Vote 7-0**
- Ordinance {O-10-57} accepting various grant proceeds & appropriating \$4500 for the Conway EcoFest. **Vote 7-0**
- Ordinance {O-10-58} accepting a donation and appropriating funds in the amount of \$5,000 for the filming of the City League Championship Baseball Game for the Parks & Recreation Dept. **Vote 7-0**
- Ordinance {O-10-59} waiving bids and appropriating funds in the amount of \$276,157 to purchase additional furnishings for the New Conway Fairgrounds. **Vote 7-0**
- Ordinance {O-10-60} appropriating insurance proceeds in the amount of \$1,117 for fire engine repairs for the Conway Fire Department. **Vote 7-0**
- Ordinance {O-10-61} appropriating insurance proceeds in the amount of 5,641.19 for vehicle repair & veterinarian services for the Conway Police Department. **Vote 7-0**
- Ordinance {O-10-62} appropriating asset forfeiture funds in the amount of \$3100 for computer & other equipment repairs for the Conway Police Department. **Vote 7-0**

- Ordinance {O-10-63} appropriating grant funds in the amount of \$3121 from the State of Arkansas for child safety seats for the Conway Police Department. **Vote 7-0**
- Ordinance {O-10-64} authorizing the reclassification a major position at the Conway Police Department. **Vote 7-0**
- Ordinance {O-10-65} regulating the possession, sale and ingestion of certain substances (K-2) and providing penalties for such regulation within the City of Conway. **Vote 7-0**
- Ordinance {O-10-66} amending the Employee Handbook in regards to Employment Benefits, Surviving Spouse/Dependent Eligibility to participate in the City's Health Care Plan. **Vote 7-0**
- Ordinance {O-10-67} waiving the requirement to obtain competitive bids for equipment repairs (dump truck) for the Street Department. **Vote 6-0 w/ Alderwoman Smith not present at the time of voting.**
- Ordinance {O-10-68} appropriating funds in the amount of \$115,200 for repairs to fire equipment for the Conway Fire Department. **Vote 7-0**

- Resolution {R-10-27} requesting the Faulkner County Tax Collector to place a certified lien on property located at 602 5th Street as a result of incurred expenses by the City. **Vote 7-0**
- Resolution {R-10-28} requesting the Faulkner County Tax Collector to place a certified lien on property located at 335 Natchez Trail as a result of incurred expenses by the City. **Vote 7-0**
- Resolution {R-10-28A} accepting the modification of the existing Conway Class 1 Landfill for the Conway Sanitation Department. **Vote 7-0**
