*On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum were present and acting; Alderman Hawkins, Alderman Grimes, Alderwoman Smith, Alderwoman Mehl, Alderman Vaught & Alderman Rhodes, Alderman Jones & Alderwoman Whitmore. Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael Garrett, and City Attorney Michael Murphy.*

***At its meeting the Conway City Council took the following actions:***

**Ordinances Passed:**

- Ordinance {O-10-117} regulating the use of public and private sewers and drains, private wastewater disposal and the installation and connection of buildings in the City of Conway. **Vote 8-0**
- Ordinance {O-10-118} waiving bids for the purchase of a new fire engine for the Conway Fire Department. **Vote 8-0**
- Ordinance {O-10-119} accepting restitution for overtime performed by the Conway Police Personnel & accepting restitution from the Prosecuting Attorney's Office. **Vote 8-0**
- Ordinance {O-10-120} appropriating and accepting grant, reimbursement and insurance funds from various agencies for the Conway Police Department. **Vote 8-0**

**Ordinances Failed: None**

**Resolutions Passed:**

- Resolution {R-10-61} approving and authorizing the Issuance hospital revenue improvement bonds for Conway Regional Hospital. **Vote 7-0 w/ Alderman Rhodes not present.**
- Resolution {R-10-62} authorizing the execution, sale, and delivery of wastewater revenue improvement bonds, Series 2010 for Conway Corporation. **Vote 8-0**
- Resolution {R-10-63} requesting the Faulkner County Tax Collector to place a certified lien on property located at 2 Cedar Oak as a result of incurred expenses by the City. **Vote 8-0**
- Resolution {R-10-64} requesting the Faulkner County Tax Collector to place a certified lien on property located at 3035 Franklin as a result of incurred expenses by the City. **Vote 8-0**

- Resolution {R-10-65} ordering the demolition of a structure located at 1910 Hillman and declaring the intent of the City to bring the property up to code, if the owner does not. **Vote 8-0**
- Resolution {R-10-66} approving various purchases through the Pay as you Sales Tax Revenue for the Conway Fire Department. **Vote 8-0**
