Resolution Passed:

R-11-09 Resolution setting a public hearing (March 8th, 2011) to discuss the closing of a fifteen foot wide utility easement abutting the west property line of Lot 1 of the Prince/Salem Station subdivision. **Vote 7-0**

R-11-10 Resolution ordering the demolition of a structure located at 1415 Lincoln Street. **Vote 7-0**

R-11-11 Resolution accepting a contract from Aramark for concessions at City of Colleges Park and Conway Station Park for the Conway Parks & Recreation Department. **Vote 7-0**

In Other Actions:

Approved the City Council minutes from the February 15th, 2011 City Council Meeting. **Vote 7-0**
