On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum were present and acting; Alderman Hawkins, Alderwoman Mehl, Alderwoman Smith, Alderman Grimes, Alderman Vaught, Alderman Rhodes, & Alderman Jones. Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael Garrett, & City Attorney Michael Murphy. Alderwoman Whitmore was not present.

Ordinance Passed:

- O-11-64 Ordinance authorizing additional personnel (Part/time Administrative Assistant II position) for the CDBG Program. **Vote 6-1 w/Alderman Vaught voting against.**
- O-11-65 Ordinance amending by reference Ordinance O-94-54 (Conway Zoning Ordinance) in reference to PUD (Planned Unit Development) to clarify regulations, procedures, and definitions. **Vote 7-0**
- O-11-66 Ordinance appropriating revenue funds in the amount of \$14,790 for repairs to a truck at the Conway Sanitation Department. **Vote 7-0**
- O-11-67 Ordinance appropriating funds in the amount of \$5,000 for expenses related to Civil Service Commission expenses and entry fire fighter testing for the Conway Fire Dept. **Vote 7-0**

Resolution Passed:

- R-11-42 Resolution requesting the Faulkner County Tax Collector to place a certified lien on property located at **1750 Arden Lane** as a result of incurred expenses by the City. **Vote 7-0**
- R-11-43 Resolution requesting the Faulkner County Tax Collector to place a certified lien on property located at **516 First Ave** as a result of incurred expenses by the City. **Vote 7-0**

In Other Actions:

- Approved the minutes from the August 9th, 2011 City Council meeting. **Vote 7-0**
- Approved the request from the Conway Bicycle Advisory Board for the appointment of Duston Morris to the board. **Vote 7-0**
- Approved the request by the Conway Bicycle Advisory Board to create designated bicycle routes within the City of Conway. **Vote 7-0**
- Approved the right of way acquisitions along Old Military Road – McNutt Road at Donnell Ridge from Mitch Hart at a cost of \$222,170. **Vote 7-0**
