On this date the City Council of the City of Conway, Arkansas met in regular session. Ordinance Passed:

- O-11-97 Ordinance amending the Conway Zoning Ordinance naming the Conway Planning Commission as the Board of Zoning/Adjustment. **Vote 8-0**
- O-11-98 Ordinance amending the Conway Subdivision (O-00-03) to allow the platting of lots with less than 100 feet of street frontage along collector, minor arterials, and major arterials. **Vote 8-0**
- O-11-99 Ordinance amending the Conway Zoning Ordinance establishing standards for mobile vendors including mobile food vendors. **Vote 8-0**
- O-11-100 Ordinance repealing O-00-22 standards for interim, construction, and temporary buildings; and amending the Zoning Ordinance to include and amend standards for accessory and prefabricated buildings, particularly, interim, construction, and temporary buildings. **Vote 8-0**
- O-11-101 Ordinance appropriating revenue funds (\$1068) to the Conway Sanitation Dept. **Vote 8-0.**
- O-11-102 Ordinance to establishing new fees to be assessed for the rental of the Conway Expo Center. **Vote 8-0**
- O-11-103 Ordinance authorizing a change in staffing levels for the Parks & Recreation Dept. **Vote 8-0**
- O-11-104 Ordinance establishing the division of the .4 mill (voluntary) assessment for the operating and maintaining cemeteries. **Vote 8-0**

- Approved a change order (#1) for Stage 1B of the New Conway Municipal Airport Construction. **Vote 8-0**
