Ordinances Passed:

- O-13-40 Ordinance to rezone property located at 2025 Tyler Street from R-2A to MF-1. **Vote 7-0**
- O-13-41 Ordinance approving of disposal of cellular telephone equipment for the IT Department. **Vote 7-0**
- O-13-42 Ordinance appropriating funds in the amount of \$21,345 to purchase network switches for disaster recovery for the Information Technology Department. **Vote 6-0-1 w/ Alderman Pruitt abstaining**
