On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum were present and acting; Alderwoman Smith, Alderwoman Mehl, Alderman Pruitt, Alderman Ledbetter, Alderman Jones, Alderwoman Whitmore & Alderman Hawkins Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael O. Garrett & City Attorney Michael Murphy. **Alderman Pruitt & Alderman Grimes were not present.**

**Ordinances Passed:**

- O-13-47 Ordinance to close the unbuilt 40 foot Vine Street right of way located between Third Avenue and Fourth Avenue. **Vote 6-0**
- O-13-48 Ordinance accepting the annexation of 120.94 acres located North of Blaney Hill Road (also known as the Old Conway Landfill). **Vote 6-0**
- O-13-49 Ordinance to enter into a lease agreement & waiving competitive bids to purchase a motor grader from Riggs CAT of Little Rock in the amount of \$1,954 per month with an option to buy the machine at the end of 36 months for \$160,000 for the Street Department. **Vote 6-0**
- O-13-50 Ordinance appropriating funds in the amount of \$19,750 received from the AR Municipal League Vehicle Program for the Conway Parks & Recreation Department. **Vote 6-0**
- O-13-51 Ordinance waiving bids for the purchase of commercial waste and recycle containers products from Cram-a-lot for the Conway Sanitation Department. **Vote 6-0**
- O-13-52 Ordinance waiving bids for the purchase of the EPI Liner from EPI Environment Products Inc. for the Sanitation Department. **Vote 6-0**
- O-13-53 Ordinance appropriating funds in the amount of \$1201 from various donors for the CFD. **Vote 6-0**

- R-13-24 Resolution to approve the new Conway Municipal Airport Business Plan. **Vote 6-0**

- Approved Right of way acquisition parcels 21, 22, 23, 24 & 25 for Prince Street Improvement (Western Avenue to Shady Lane). **Vote 6-0**

Approved Disposals of property for various departments (mostly IT items) that will be removed from the fixed assets (inventory) for the City of Conway. **Vote 6-0**

Approved Bid from Springhill Specialty Trailer for a smokehouse in the amount of \$37,900 for the CFD. **Vote 6-0**

**Held in Committee/No Action Taken:**

Ordinance establishing responsibility for tarping and securing materials/debris during transportation within the Conway Sanitation Department. **Vote 6-0**

Ordinance authorizing city officials and city employees to be employed by or otherwise serve in a dual capacity with the Faulkner County Solid Waste Management District. **Vote 6-0**
