- Approved Minutes from the May 28th, 2013 City Council meeting. **Vote 7-0**
- Approved Jeremy Gardner for a four year term on the Advertising and Promotion Commission. **Vote 7-0**
- Approved Jamie Gates & Susan Wilson for a six year term on the Conway Civil Service Commission. **Vote 7-0**
- Approved Bid from Resurgence Demolition in the amount of \$1500 for the demolition of structure located on property located at 2002 Prince Street. **Vote 7-0**
- Approved Bid from LR Equipment Sales in the amount of \$82,347 for a tractor with Boom Mower. **Vote 7-0**
- Approved Bid from Paladino Nash for the 2013 Sidewalk Improvements in the amount of \$183,105.04. **Vote 7-0**
- Approved Tract 57 (Loya) counter offer in the amount of \$17,697 for the Western Arterial Loop (Baker Willis Parkway) South Interchange Right of way Acquisition. **Vote 7-0**

- Denied Tract 62 (Maynard) counteroffer request in the amount of \$10,840 for the Western Arterial Loop (Baker Willis Parkway) South Interchange Right of way Acquisition. **Vote 7-0**
