On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum were present and acting; Alderwoman Mehl, Alderman Pruitt, Alderman Ledbetter, Alderman Jones, Alderwoman Whitmore, & Alderman Hawkins Also, present and acting: Mayor Tab Townsell, City Clerk/Treasurer Michael O. Garrett & City Attorney Michael Murphy. **Alderwoman Smith and Alderman Jones were not present.**

Ordinances Passed:

- O-13-67 Ordinance authorizing the issuance of a promissory note to provide short term financing for Prince Street Improvement for the Street Dept; and repealing (O-09-103) and O-13-61. **Vote 6-0**
- O-13-68 Ordinance amending Ordinance No. O-12-47 which authorized the issuance of a promissory note to provide short term financing for the relocated Conway Municipal Airport. **Vote 6-0**
- O-13-69 Ordinance to rezone property located at 2645 Prince Street from O-3 to C-2. **Vote 6-0**
- O-13-70 Ordinance to set dumping or “tipping” sanitation fees for businesses and residents. **Vote 6-0**
- O-13-71 Ordinance to establish the rates for residential sanitation collection fees starting September 1st, 2013 at a rate of \$17.00 for the Sanitation Dept. **Vote 6-0**
- O-13-72 Ordinance accepting a giftcard donation for \$500 (giftcard) from Petco for the AWU. **Vote 6-0**
- O-13-73 Ordinance appropriating funds in the amount of \$14,000 for the Civil Service expenses for the entry level firefighters and police officer testing. **Vote 6-0**
- O-13-74 Ordinance appropriating funds in the amount of \$2000 for the CEO’s for Cities Central Arkansas Cluster. **Vote 6-0**

Resolution Passed:

- R-13-25 Resolution amending and clarifying Resolution No. R-11-73 to specifically allow the payment of debt service on the Prince Street major street. **Vote 6-0**

In Other Actions:

- Approved Minutes from the June 25th, 2013 City Council meeting. **Vote 6-0**
- Approved Amanda Potter Cole to the Bicycle & Pedestrian Advisory Board. **Vote 6-0**
- Approved Disposal of inventory for the Sanitation Department for a 2006 Condor Freightliner (Tag# 2521) & 2008 Rear Load Refuse (Tag# 2434). **Vote 6-0**
