- O-17-07 Ordinance to rezone the property located at Donnell Ridge and Mattison Road from A-1 and R-1 to a PUD. **Vote 6-0**
- O-17-09 Ordinance to rezone property located at 129 Eve Lane from A-1 to R-1. **Vote 5-0**
- O-17-10 Ordinance appropriating funds in the amount of \$5,598.40 for the repairs of Engine 1 for the CFD. **Vote 5-0**
- O-17-11 Ordinance accepting and appropriating grant funds in the amount of \$1,500 and donation funds in the amount of \$236 for the Conway Fire Department. **Vote 5-0**
- O-17-12 Ordinance to waive the competitive bid process to purchase tasers & cartridges in the amount of \$25,100 from Taser International for the Conway Police Department. **Vote 5-0**
- O-17-13 Ordinance to waive the competitive bid process to purchase concealment vests from Teeco Safety in the amount of \$13,804 for the Conway Police Department. **Vote 5-0**

- Approved To rebid the remediation work for the Conway Scrap Metal Site project. **Vote 5-0**
- Approved Transportation Services for FY2017 for the Independent Living Services (\$30,000) Faulkner County Council on Aging (\$69,000) & Boys & Girls Club of Faulkner County (\$78,000). **Vote 5-0**
- Approved Agreement with Conway Housing Authority for one fully equipped community policing officer from the Conway Police Department. **Vote 5-0**
- Approved To retire K9 (Chewie) from the City's inventory and to turn him over to his handler, Officer Matthew Edgmon for the Conway Police Department. **Vote 5-0**

Consideration to grant a right of way easement at the corner of College and Salem to Conway Corporation.

Consideration to approve a conditional use permit for Mt. Carmel Community to allow a nursing home at property located at 2505 Salem Road in an A-1 zoning district.
