**Ordinances Passed:**

- O-16-07 Ordinance authorizing changes to reflect a reclassification of one part time technician to a full time technician and to appropriate \$3,000 for the Conway Airport Department. **Vote 7-0**
- O-16-08 Ordinance to rezone property located at 711 & 723 Factory Street and 700 & 714 First Street from R-2A to C-3. **Vote 7-0**
- O-16-09 Ordinance appropriating funds and entering into an agreement with White-Daters Associates for the professional service contract for Phase 2 of Conway Station Park. **Vote 6-0**

**Resolutions Passed:**

- R-16-04 Resolution establishing the intent of the City to annex certain lands along Mill Pond Road and Bronnie Lane which have been completely surrounded by incorporated limits of the City. **Vote 7-0**
