*On this date the City Council of the City of Conway, Arkansas met in regular session. The following members being a quorum were present and acting; Alderman Hawkins, Alderman Grimes, Alderwoman Mehl, Alderman Ledbetter, Alderwoman Smith, Alderman Jones and Alderwoman Isby. Also, present and acting: City Clerk/Treasurer Michael O. Garrett & City Attorney Chuck Clawson. **Mayor Townsell and Alderman Pruitt were not present. Alderman Hawkins presided over the meeting.***

**Ordinances Passed:**

- O-16-69 Ordinance to rezone property located at 2522 College Avenue from R-1 to O-2. **Vote 7-0**
- O-16-70 Ordinance rezoning property identified as the 400 Block of Ingram Street including properties located at 420 2<sup>nd</sup> Street and 401 Monroe Street from R-2A to PUD. **Vote 6-0 w/ Alderman Grimes abstaining.**
- O-16-71 Ordinance appropriating insurance proceeds funds received from the Municipal Vehicle program for the Conway Sanitation Department. **Vote 7-0**
- O-16-72 Ordinance accepting the bid & appropriating funds for the replacement of the slide gates at Lake Beaverfork for the Parks & Recreation Department. **Vote 7-0**
- O-16-73 Ordinance appropriating reimbursement funds received from various entities for the Conway Police Department. **Vote 7-0**
- O-16-74 Ordinance waiving bids for the restoration of the Springfield/Des Arc Bridge and authorizing the Mayor to enter into an agreement with Workin' Bridges. **Vote 7-0**

- R-16-19 Resolution setting a public hearing for July 12, 2016 @ 6:30pm to discuss the naming of a new road that would connect Mill Pond Road to Old Military Road to Emphy Trail. **Vote 7-0**
- R-16-20 Resolution setting a public hearing for July 12, 2016 @ 6:30pm to discuss the renaming of Sand Gap Road to JW and Pat Brown Blvd. **Vote 7-0**
- R-16-21 Resolution requesting the Faulkner County Tax Collector place certified liens on property located at 66 Briarwood Cir in the amount of \$173.25 as a result of incurred expenses by the City. **Vote 7-0**

Approved Special permit that allowed a temporary water park located in the 2200 Block of East Oak Street (review). **Vote 7-0**

Consideration to amend conditional use permit no. 1323 (which allowed for a public stable) to change the name of the person tied to permit due to change in property ownership. **Vote 7-0**

Discussion regarding a waterline relocation by the City of Mayflower for the project associated with the Conway Western Loop (Baker/Wills Parkway). **Vote 7-0**
