Ordinances Passed:

- O-17-23 Ordinance authorizing the reclassification of a GIS Coordinator position to a planner position within the Planning and Development Department. **Vote 7-0**
- O-17-24 Ordinance appropriating insurance reimbursement funds in the amount of \$3,681 for the Airport Department. **Vote 7-0**
- O-17-25 Ordinance appropriating insurance proceeds funds in the amount of \$13,036.93 to the Parks & Recreation Department. **Vote 7-0**
- O-17-26 Ordinance accepting and appropriating funds in the amount of \$166,472.50 received from the Advertising and Promotion Commission for cost associated with the completion of the Conway Event Center. **Vote 7-0**

- Approved Disposing of inventory (computer equipment) for the Information Technology Department. **Vote 7-0**
