Ordinances Passed:

- O-17-56 Ordinance closing a portion of the 20 foot utility easement on Lot 5 of McCracken subdivision. **Vote 6-0**
- O-17-57 Ordinance establishing rates for services charged for the electric system at Conway Corporation. **Vote 6-0**
- O-17-58 Ordinance amending O-16-46 establishing water rates for residential customers who have separate water meter for private fire protection at Conway Corporation. **Vote 6-0**
- O-17-59 Ordinance appropriating funds in the amount of \$10,000 for the cost of a geophysical study for Lollie Levee near the Conway Airport. **Vote 6-0**
- O-17-60 Ordinance appropriating funds in the amount of \$5,500 to replace the primary airport windcone and pole at the Conway Airport. **Vote 6-0**
