- O-17-123 Ordinance accepting and appropriating funds in the amount of \$17,773.78 for the Spencer Street Brownfield Cleanup project administered by the Planning & Development Department. . **Vote 6-0**
- O-17-124 Ordinance renaming a portion of South Amity Road to Crain Drive; this change will go into effect on January 1st, 2018. **Vote 6-0**
- O-17-125 Ordinance appropriating funds in the amount of \$75,000 for the Bean Street Improvements for the Parks & Recreation Department. **Vote 6-0**
- O-17-126 Ordinance appropriating funds in the amount of \$1,000 received from Walmart for the Fire Department. **Vote 6-0**
