CR-05 - Goals and Outcomes

Progress the jurisdiction has made in carrying out its strategic plan and its action plan. 91.520(a)

This could be an overview that includes major initiatives and highlights that were proposed and executed throughout the program year.

The 2020 Consolidated Annual Performance and Evaluation Report (CAPER) assessed, the final program year of the 5-year 2016-2020 Consolidated Plan. The primary focus of this report is to summarize the accomplishments in the use of Community Development Block Grant (CDBG) entitlement funds and program income that supports numerous housing and community development priorities identified in the City of Conway's Consolidated Plan.

Throughout 2020, the City of Conway's main initiatives and focus were to continue the improvement of community facilities and public services. The program Year 2020 was no ordinary program year amidst the COVID-19 Global Pandemic. We received CARES Act funding that was geared towards the 2019 project and the amendment of the 2019 Annual Action Plan to accommodate services such as the emergency rental & utility assistance program and small business emergency grants. In addition, due to restrictions and shutdowns during the pandemic, several of our public services felt the effects. One major effect being the decline in clients, especially for our services that focus on higher-risk persons. One service, Young Empowered Sisters (Y.E.S.) was unable to spend its funding due to the Covid-19 travel restrictions and the funding was reallocated to another project. Despite the challenges in 2020 with it being the year of a Global Pandemic, we were able to continue our assistance with transportation efforts for the mentally and developmentally disabled, homeless, senior citizens, abused women, and after school programs for children. Overall, we were able to meet 90% of our persons assisted for public services.

The program Year 2020 was the final year of our 5-year Consolidated Plan. During this last year we were able to start on the final phase of the 5th Avenue Park Improvement, a project we have assisted in funding since 2018. The 5th Avenue Park is in a low-income area of the City of Conway. Over the years, the park has not been as utilized as other parks in the city, however, with the addition of the splash pad in 2018, updated park equipment in 2019, and the addition of pavilions and sidewalks for walkability, this park has become one of the most popular parks in our city.

With the 5th Avenue Park completion in 2020, no funding was allocated towards our Overnight Emergency Shelter. CARES Act funding was received that we will utilize towards the shelter, and we will continue to focus our efforts on the homeless community and our Overnight Emergency Shelter.

Highlights include:

Creating safe, and suitable living environments in low-to moderate income areas as a goal by improving public park facilities. These improvements were addressed in the 5th Avenue Park Improvement project which is in a low to moderate income area.

Assess how the jurisdiction's use of funds, particularly CDBG, addresses the priorities and specific objectives identified in the plan, giving special attention to the highest priority activities identified.

Federal CDBG funds were dedicated in the City of Conway to solve identified community challenges and meet priority needs. The program Year 2020 projects selected to address needs and objectives in the 2016-2020 Consolidated Plan and 2020 Annual Action Plan:

- 1. Repair and maintain streets and sidewalks
- 2. Enhance the capacity of the City's drainage and stormwater runoff systems
- 3. Increase the supply of affordable suitable housing
- 4. Provision of additional community facilities and public services

43% of the 2020 funding was utilized to complete the 5th Avenue Park improvements. Following the addition of the splash pad in 2018, the city wanted to continue its investment in the park. This Park is the only park located in this low-to-moderate area that houses over 700 residents nearby. Initially, the 5th Avenue Park project was anticipated to utilize 65% of the 2020 funding, however, after the start of the project, we assessed that the additional funding was no longer needed, and reallocated the \$100,000 FY2019 project—the overnight emergency shelter. We will continue to assess each year the use of these transportation funds, however, we will now shift our focus to the pandemic and post-pandemic services that are now being prioritized in our city.

Narrative

Area and citywide benefit projects such as parks, transportation, spot blight nuisance abatement, sidewalks, and ADA accessibility improvements, the racial composition data above was estimated using information from agencies CDBG funded to provide public service. These numbers are also in accordance with the 2010 US Census profile for race and ethnicity.

The City of Conway's population according to the 2010 Census consists of a 23.6% minority population. The profile breakdown of Race and Hispanic Origin according to the United States Census Bureau is as follows: 76.3% White, 13.4% African American, 1.3% American Indian & Native American, Asian 5.9% 0.2% Native American/ Pacific Islander and Two or More Races making up 2.8% with the African American population being the largest minority in the city of Conway. The composition table above indicates the 2020 CDBG program participants were as follows: 38% African American, 61% White, and 1% were of another Ethnic minority.

CDBG outreach includes residents, housing providers, non-profit organizations, organizations serving homeless, veterans, families, youth, special needs residents, private and public agencies, community leaders, business leaders, and organizations potentially discharging residents into homelessness. Special emphasis is placed on efforts to reach low- to moderate-income households in target areas. The City of Conway facilitates collaborative efforts through meetings, presentations, neighborhoods, consultations, committee and community meetings, the Analysis of Impediments, and Continuum of Care meetings

The City of Conway's CDBG amount of funding received makes it challenging to leverage funding at times. However, in funding our 5th Avenue Park, which is in a low-income area, CDBG was able to leverage funding with the City of Conway's Parks and Recreation Department to complete the final phase for improvements. CDBG continues to leverage its funding with nonprofits that provide transportation services for the homeless, mentally ill, disabled children and adults, and low-income children.

Discuss the difference between goals and outcomes and problems encountered in meeting these goals.

In 2020, the Annual Action Plan did not list goals for housing and homelessness. Again, we focused our last year of our Consolidated Plan on community facility improvements such as the 5th Avenue Park. We are continuing to work on the revitalization of the Pine Street Neighborhood, but no CDBG funding has been allocated towards this project since 2016/2017. At this point, the private developer, Summerwood Development, has completed 4 owner-occupied homes and 3 of the 4 have utilized Down Payment Assistance from the funding invested over the years in the neighborhood.

Unfortunately, all 12 houses have not been completed due to the stall of many projects following the pandemic. Since the start of 2021, as the pandemic has slowed, we have seen an increase in interest surrounding



the homes. We are anticipating that the surge of the housing market will peak more interest and the majority of the homes are occupied by 2023.

Discuss how these outcomes will impact future annual action plans.

In the future, we will refocus our funding utilization back to homelessness. We received additional CARES Act funding in 2020, however, the funding was utilized in an amendment for our 2019 Annual Action Plan, rather than 2020. In 2021, we will continue funding our overnight Emergency Shelter and are anticipating the continuation of the remodel of the property located at 1116 Gum Street. We will be able to provide more insight and updates on the overnight emergency shelter in the 2021 CAPER.

Evaluate the jurisdiction's progress in meeting its specific objectives for reducing and ending homelessness through:

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

With the creation of the city's homelessness task force in 2017, the city will continue to educate the community on how to identify the individual needs of homeless persons. The various agencies that are involved in the task force, all serve the different needs that vary in the homeless community.

The task force created a resource directory for citizens to be educated on the focus of each agency in an effort to direct any person who needs to an agency that will be able to properly assist them based on their individual needs.

Addressing the emergency shelter and transitional housing needs of homeless persons

Conway is very fortunate to have four organizations in the City of Conway that provide supportive housing for all of Faulkner County. Bethlehem House is a true transitional housing shelter that provides for the needs of the homeless in Conway. The Rise Hope is Conway's only women's shelter that provides supportive housing to women and children that are in abusive environments. The City of Hope Outreach supports two LMI mobile home parks and provides emergency shelter for two singles at a time. The Ministry Center is also an organization that provides services for homes and office space for several non-profits that directly impact the homeless and low incomes. In addition to these housing agencies, the Community Action Program of Central Arkansas provides utility assistance.

A frequent point in time count is completed for all the facilities in order to keep up with the number of homeless being served in the three county areas. In 2019, CDBG purchased a vacant building and a neighboring home. Since the purchase of this building with the goal of renovating it into an Overnight Emergency Shelter, we have secured an architecture firm—Level 5 Architects and they have completed a design for the overnight emergency shelter that will also be post-Covid friendly. This project is estimated to be complete in late 2022. We used the additional allocation **(\$334,809)** that we received from the CARES Act funding to fund expenses related to the Overnight Emergency Shelter. We plan on using the project funding received for 2021 as additional funding for the shelter.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: likely to become homeless after being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); and, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs

The City of Conway at this current time is not an agency that can fully address the needs. However, the city does provide support and CDBG funding to assist agencies to help make the transition to permanent housing and



independent living much easier and to prevent these individuals and families from becoming homeless again.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

Prior to Covid, the homeless task force met monthly to discuss these various options to alleviate the number of homeless persons in our city. There were sub-committees within the task force that focused on employment for homeless persons. In 2019, the city was able to employ persons recommended by nonprofit agencies that focus on homelessness. This was the third year for the "work local" program, city is in the process of creating job opportunities within the city for those who are struggling with chronic homelessness to help them gain a more consistent income to help support them and/or their family.

In the future, the city plans on collaborating with other local businesses to participate in the "work local" program. We believe that creating these opportunities will allow those who are struggling with having consistent housing to transition to more permanent housing and prevent them from becoming homeless again. In addition to employment opportunities, the rental assistance program (implemented through the CARES Act funding) also helped families and individuals who may have otherwise been facing eviction and homelessness, with up to 3 months of consecutive rental assistance.

Actions taken to address the needs of public housing

Conway Housing authority provides 92 units for low-income public housing for families, the elderly, and persons with disabilities. 300 families receive assistance with rent through the Section 8 Rental Assistance Program, where a family finds a dwelling unit that meets local and federal guidelines. There are 112 apartments available for elderly persons 62 years of age and older or disabled. There is a waiting list for these programs. Rent is based upon 30% of their adjusted income. Eligibility: low-income family, elderly or disabled. Verification is required for eligibility.

Actions taken to encourage public housing residents to become more involved in management and participate in homeownership

The city is also still in the process of working with a private developer to build 12 cottage homes. Currently, 4 homes have been constructed and are occupied. Covid-19 has delayed the project some, however, in 3 of the 4 homes owners were eligible for the homebuyer subsidy program offered by the city through CDBG. Seven of the 12 cottage homes will participate in the homeownership subsidies that will allow the buyers to receive assistance for fees and the down payment associated with purchasing a home. The income eligibility will be based on the latest HUD income limits for low to moderate-income persons based on family size

Actions taken to provide assistance to troubled PHAs

Conway Housing Authority is not designated as troubled.

Actions taken to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment. 91.220 (j); 91.320 (i)

The City of Conway is committed to establishing and maintaining facilitative relationships with organizations and institutions that are service providers in an attempt to lessen the gaps in the institutional structure. Non-profit, private, and public entities are encouraged to provide housing opportunities. The City of Conway will continue to engage in and support collaborative efforts combining local government, non-profit organizations, and private section enterprise and resources to low- and moderate-income residents. The City will preserve and protect existing housing units as a means of stabilizing neighborhoods and enhancing property values.

The City of Conway Housing Authority has an excellent relationship with the Mayor, the Assistant to the Mayor for Community Development, and the City Council. The City of Conway City Council approves all Conway Housing Authority Commissioners, and the City oversees and assists the Housing Authority in every way possible. Over the past 10 years, the city has targeted the Pine Street Neighborhood for redevelopment. This historical African-American neighborhood sits in the heart of the city near downtown. Pine Street's demographics show a high percentage of rental homes, a population that is less educated with higher poverty rates than the rest of the city. The housing stock within the neighborhood is also smaller and older than the areas nearby it.

In 2019, the city partnered with a private developer to completed Old Conway Village. The developers received a low-income housing tax credit which allowed renters to buy their home after 15 years. In doing this in other cities, they reported that they have observed that tenants tend to take better care of their homes and treat it as though they are already homeowners. This leads to better quality renters, increasing the quality of the neighborhood, in turn eliminating the negative effects that can come with affordable housing.

Actions taken to address obstacles to meeting underserved needs. 91.220(k); 91.320(j)

All funding went to serve low to moderate-income individuals. Public Services, namely transportation, also constitute a significant portion of spending for 2020. This program year, CDBG was able to continue the renovation of the 5th Avenue Park, a park in a low-income area. Prior to the renovation, the park was not being utilized as much as other parks in the city.

After the renovations and the addition of a splash pad, the park has seen a tremendous increase in attendance. The City also understands that transportation is more of an obligation to the low to moderate income citizens than other services and fulfills these needs first. The subgrantees providing transportation with CDBG funding cater to homeless, abused women and children, disabled adults, and low to moderate income children for after school care. The purchase and beginning phase of the renovation of the overnight emergency shelter allows the city to shift its focus to the homeless population, a severely underserved population.



It is our hope that this shelter allows those who are homeless to receive safe shelter and can eventually transition back into a stable lifestyle.

Actions taken to reduce lead-based paint hazards. 91.220(k); 91.320(j)

CAPCA housing staff has all been certified on lead paint rules. Through CAPCA, our strategy for addressing:

lead-based paint in home rehabilitation includes:

- Education of Household members
- Incorporation of lead-based paint regulations in contracts
- No lead-based paint to be used in new construction or rehab.
- All structures built before 1978 are assumed to involve lead based paint.
- All surfaces are required to be covered with materials such as hardboard, plywood, drywall, or plaster before any repair or repainting.

Actions taken to reduce the number of poverty-level families. 91.220(k); 91.320(j)

Expanded economic opportunities include job creation and retention; establishment, stabilization and expansion of small businesses, the provision of public services concerned with employment; the provision of jobs involved in carrying out activities under programs and activities; availability of mortgage financing for low-income persons at reasonable rates using nondiscriminatory lending practices; access to capital and credit for development activities that promote the long-term economic and social viability of the community; and empowerment and self-sufficiency opportunities for low-income persons to reduce generational poverty in federally assisted and public housing

Actions taken to develop institutional structure. 91.220(k); 91.320(j)

The City of Conway is committed to establishing and maintaining facilitative relationships with organizations and institutions who are service providers in an attempt to lessen the gaps in the institutional structure. Non-profit, private, and public entities are encouraged to provide housing opportunities.

Actions taken to enhance coordination between public and private housing and social service agencies. 91.220(k); 91.320(j)

Old Conway Village was completed in the summer of 2019. It was well received by the Conway community and the homes have remained full since the opening. In addition to Old Conway Village, Summerwood Inc. is in still in the process of developing 12 cottage homes on Spruce Street in the Pine Street Neighborhood. Four of the twelve homes are complete and owner occupied. Three buyers qualified for the down payment assistance program. Due to Covid, there has been a delay in the development process, however, in recent months we have seen interest in the homes



begin to peak again.

The city has partnered with private developers with experience in developing other private areas in neighboring cities and using Low-income housing tax credit. Although the homes are not considered public housing, the homes include subsidies that will assist in reducing the cost and making them more affordable and the renter will have the opportunity to purchase the home at a lower expense after fifteen years. Both private developers developed housing and units that are affordable and reach our low to moderate income population

Identify actions taken to overcome the effects of any impediments identified in the jurisdictions analysis of impediments to fair housing choice. 91.520(a)

One of the impediments identified in the analysis of impediments to fair housing is the disproportionately high home purchase loan denial rates that exist for racial and ethnic minorities. With one of our focuses being on the Pine Street Revitalization--an area that is predominantly African American, the city is building homes in that area that are affordable and have a path to homeownership.

With this path, low to moderate income renters in that area will be able to eventually own their homes without being denied loans, ideally decreasing the amount of racial and ethnic minorities that are denied loans.



CR-40 - Monitoring 91.220 and 91.230

Describe the standards and procedures used to monitor activities carried out in furtherance of the plan and used to ensure long-term compliance with requirements of the programs involved, including minority business outreach and the comprehensive planning requirements

The Grantee takes an active role in all non-public service projects performing onsite visits throughout execution. If the Grantee does not directly oversee the project, onsite monitoring is conducted at least once per year. The CDBG Director and the CDBG coordinator complete weekly site visits and take photos of both of the developments. While the townhomes were being constructed, weekly site visits and communication with the developers were a high priority. the same process is being followed for the cottage homes. All subrecipients are required to enter into an agreement with the city that states all expectations and guidelines of the grant funding. Subrecipients attend a post award meeting after notice of funding to review said agreement and answer any questions. Monitoring reviews of the subrecipient are also completed each fiscal year. This allows the CDBG administrator to directly assess the implementation of the grant and ensure that HUD income requirements are being met. The CDBG administrator also attends agency board meetings as an additional observation measure. Transportation is a major need in Conway as identified by several studies including a health care assessment by Conway Regional Medical Center and a needs assessment by the United Way of Central Arkansas. The Conway City Council expressed an interest in providing transportation as a priority. Transportation programs funded by Conway CDBG benefit homeless, abused women and children, developmentally disabled adults, and an after-school program.

Transportation programs have a dramatic effect on our community in that at-risk populations are provided a better quality of life through CDBG funded programs. High risk children now have tutoring, mentorship, and sports activities after school rather than being home alone. Senior Citizens are able to remain in their homes for years with an enhanced quality of life rather than relying on assisted living or a nursing facility. Homeless adults abused women and disabled adults are able to find and maintain employment. Subrecipients are given an estimate as to when funding will be available during pre-application training. All subrecipients are made aware that funding will only be reimbursed for money spent after signing the contract agreements. The city will continue to improve the monitoring process and will keep documentation of correspondence with subrecipients and monitoring details.

Due to the Covid-19 pandemic, monitoring face-to-face has been a difficult task to achieve. Desk monitoring is something that the CDBG Administrator completed with all agencies in the 2020 program year.

There was also a 5-day comment period prior, per HUD regulations (due to the pandemic), prior to the submission of the Plan allowing citizens the opportunity to voice any questions or concerns that they have about the 2020 Action Plan. The application window was open for 30 days with two mandatory trainings held prior to applying. All of this information was submitted to the local newspaper and on the City's website. The Action Plan draft was also submitted on the city's website for citizen review.

Years Accomplishment Narrative

Benefitting

The Pine Street Revitalization project was a major undertaking for the City of Conway. We used multiple years of funding to complete this project. Completed, this project now boasts a major pedestrian connection in the Historic Pine Street Community between Ingram Street and Harkrider Street, improving pedestrian safety, providing better handicapped access in the area, and affordable housing for the community.

The entire project included land acquisitions, infrastructure improvement, utilities, parking, sidewalk improvements, and drainage improvements to Siebenmorgen road, to include drainage connections from Lincoln Street which experienced flooding due to elevation issues with the street.

After work was finished in that area the city partnered with DHTC to break ground on affordable housing that consisted of 44 housing units. Of the 44 homes, 3 homes would be for persons with 30 percent area median income or lower, 32 homes for persons with 60 percent area median income or lower, and 9 homes will be unrestricted. All homes will be 3 bedrooms, 2 bath homes. These homes were built by a local contractor, Salter Construction. This housing development will help maximize the city $\tilde{A}\phi \hat{A}_{\dot{c}}\hat{A}_{\dot{c}}$ s investment in this area while meeting the goal of providing affordable housing in this historic area.

The final part of the revitalization will be the Spruce Street Cottage Project, which is a partnership with Summerwood Inc.

This project will follow a pocket neighborhood model, one of the first in Conway. Seven of the twelve homes will be eligible for a down payment subsidy for homebuyers. Potential homebuyers will have to meet the income limits outlined by HUD to qualify for the subsidy. The remaining 5 homes will be sold at market rate. The homes will be a mix of 3 bedroom 2 bath and 2 bedroom 1 bath.
